Our next agility class starts Wednesday, August 4, 2010. These classes will run eight weeks. We will be holding two classes:

- 6:00 to & 7:30 pm---Foundation/Beginning/Intermediate---for dogs with no prior experience and Intermediate---for dogs that have completed Foundation/Basic
- 7:30 to & 9:00 pm---Competition---for dogs that have completed Intermediate, have instructor permission, and are competing.

Dogs will be placed according to their ability. NO aggressive dogs will be accepted in this class. Basic obedience is needed at all levels except Foundation. Proof of vaccination is required before dog can attend class.

We will be holding classes outside at Tautphaus Park, west of the fountain, on Fountain View Drive. Please dress accordingly. Class participants are expected to help set up and take down the equipment for their class. It is a privilege to be able to use the park and all class participants are expected to respect the rules of the class and the City of Idaho Falls. Please respect Idaho Fall's leash law and keep your dog on leash except when participating in class. Your dog should be exercised before coming to class, please do not exercise your dog off lead at the park before or after class. We do not want to lose the privilege of training in the park. Dogs not participating in class will need to be crated, on leash, or left in car.

Please complete and return the registration form with fees, payable to USRVDTC, at least one week prior to the first class. Class space is limited and only "paid registration" guarantees a spot in the class. USRVDTC club members must also complete and submit registration form.
