### May/June Obedience Classes

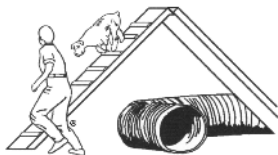

## Meet our Members

### **Barbara Friedrich**

I have had dogs since I was 3 years old - and that is a VERY long time! My first dog was a Saint Bernard - he bit me in the face - this required stitches and that was the end of our having Saints! Then we raised Cocker Spaniels. After the last one of those died we got an English Setter followed by a Boxer. None of these dogs ever went to obedience school!

Then came college followed by our marriage in 1959. We received a Standard Poodle for a wedding gift, and he went to class here in Idaho Falls at the age of 7½ years. We had two more Standard Poodles, who also went to school and both achieved the UDT title. After those were gone we decided to change breeds and we got two littermate Portuguese Water Dogs. Bad idea - they never grew up. They both achieved the UDT title and the female got her Novice Agility - 1 month before she died of cancer at the age of 11. After the male died we went for 1½ years with no dogs. Decided we had better get another dog before we were both too old to train!

We looked for a performance dog and were truly blessed to be picked to own Libby. She has surpassed anything we ever expected in our dogs. We share showing Libby - I show her in Obedience and Rally and Carl in Agility and Tracking. She first received her Tracking Dog title, then went through the Obedience degrees topping them with a UDX last summer. Along the way she received several high in trial and high combined awards. She started in Novice A Agility and went all the way to receive her MACH title last winter. She earned her Rally Excellent title and has 6 legs toward her RAE title - she has never NQ'd in Rally. She also earned her Apprentice Water Dog title in 2005. Libby is a well rounded dog that loves everyone and every dog she's ever met including our mailman.

We joined USRVDTTC in 1976. Two months after joining the club, Carl was President and I was Secretary. That is the fast way to become indoctrinated! Since then I have been President, Treasurer, Secretary, Board Member, Obedience Chairman, Agility Secretary, Agility Chairman - Hospitality, Trophy Chairman, Publicity, Delegate Liaison, Canine Good Citizen, etc. etc. etc...

I decided I had something to give back to the sport of obedience, so applied and became an AKC Obedience Judge 26 years ago in 1981. In 1985 I became a Tracking Judge, and in 2004 a Rally Judge. We have met many wonderful people and have traveled all over the US including Alaska four times and Hawaii three. We are going to both those states again later this year.

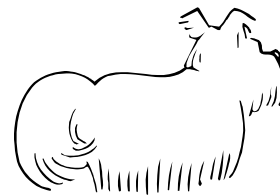


**Thank You!**

February 15, 2007

The regular monthly meeting of the Upper Snake River Valley Dog Training Club was called to order at 7:35 p.m. by President, Suzanne Belger, on February 15, 2007, at Godfather=s Pizza in Idaho Falls, Idaho.

Guest speaker, Dr. Quirel from Upper Valley Veterinary Hospital, did a presentation about hip dysplasia, OFA and PennHip procedures.

Equipment Manager: The FAST equipment is all ready for the trial. The dog walk has been stabilized and is ready to go.

CGC Chairman: Judy Grof announced that the Canine Good Citizen testing will take place on February 20<sup>th</sup> at the City Activity Center (same place as the classes were held), at 6:30 p.m. Volunteers were asked to show up to help. Vicki Robinson, as last years CGC Chairman will be there to help as needed.

OB Training Director: Classes are finished except for CGC testing. The next classes will begin May 9<sup>th</sup>, at Tautphaus Park. Times will start with Rally at 5:30 p.m., Basic at 6:30 p.m., Intermediate at 7:30 p.m.

OB Trial Chairman: Duane Loomis sent via Cheryl that judges for 2007 have been secured. They are Ms Karen TenEyck of California, Miss Nancy Pollock of New Mexico, and Mr. Pat Alvarez of California.
