To: Prospective Class Members,

Our next obedience and rally classes will start on June 3, 2009 at Tautphaus Park. Classes will meet west of the fountain along Fountain View Drive. Each class will be held once a week for eight weeks on Wednesday nights. The classes being offered and the purpose of the class are as follows:

Basic Obedience: This class is for dogs and handlers that have never taken a class. The purpose is to teach the handler to train the dog to a basic level of obedience. It is specifically designed to prepare the handler and dog to take AKC's Canine Good Citizen test. Dogs may be entered in this class (or any of the classes) more than once.

Intermediate Obedience: This class is for anyone who wants to achieve better communication and control with his/her dog. It is specifically designed to prepare the handler and dog for AKC's Novice Obedience class offered at AKC Obedience Trials.

Obedience/Utility: This class is being provided to prepare handlers and dogs for Open Obedience and Utility classes offered at AKC Obedience Trials.

Rally: Rally is a new dog sport that provides a stepping stone from the AKC Canine Good Citizen® program to the world of obedience or agility. Rally offers both the dogs and handlers an experience that is fun and energizing. Rally is the first level of three levels and is usually held at AKC Obedience Trials.

Advanced/Excellent Rally: This class is being provided to prepare handlers and dogs to participate in AKC's Advance Rally and Excellent Rally classes.
