#### Tracking Test / TD

#### **ENTRY INFORMATION**

Entries close at 5:00 p.m. MDT, Saturday, September 09, 2017. Fees must accompany entries. All checks and money orders for Tracking Test/TD are to be made payable to USRVDTC, in U.S. FUNDS, and mailed or hand-carried to Rochelle Mason, 212 Gettysburg Lane, Idaho Falls ID 83402. No entry will be accepted, canceled, or substituted except as provided in Chapter 11, Sections 3-7, of the Rules Applying to Dog Shows. <a href="Upper Snake River Valley Dog Training Club is NOT accepting online entries.">Upper Snake River Valley Dog Training Club is NOT accepting online entries. Please mail entries so that they arrive on or before closing. Telephone, telegraph, and unsigned entries cannot be accepted and will be returned.

#### ONLY One Entry per dog will be accepted.

The entry form for a dog that has "not passed" an AKC Tracking Test, must be accompanied by an ORIGINAL certification statement, dated within one year, signed by a person who has been approved by the American Kennel Club to judge tracking tests, certifying that the dog is considered to be ready for such a test.

**No entry** shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. The club and/or its Test Secretary assumes no responsibility for wrong or incomplete information given by the owner or the owner's agent for entering the dog. THE RESPONSIBILITY FOR THE COMPLETENESS OF ANY ENTRY RESTS SOLELY WITH THE ENTRANT.

**Entries not on official AKC entry forms** or photocopies of entry forms without the agreement and rules on the reverse side of the official AKC agility entry form are invalid and will not be accepted.

**Illegible or incomplete entries** will not be processed and will be returned to the exhibitor. Entries not accompanied by the correct fees or a returned check do not constitute a valid entry. The Test Secretary will add a \$25.00 collection fee to the amount of each returned check. Those that have checks returned for NSF will be on a cash-only basis for all future tests.

**DRAWING OF ENTRIES** A maximum entry of 12 dogs is set for this Tracking Test/TD. ALL ENTRIES will be accepted up to the Closing Date, even though the advertised limit has been reached. A random drawing will be held at the Secretary's residence in Idaho Falls, ID at 5:00 p.m. on September 19, 2017, to determine which entries and numbered alternate's position corresponding to the order in which they are drawn.

#### TRACKING TEST/TD RULES & REGULATIONS

DOGS holding the Tracking Dog or the Tracking Dog Excellent Title shall not be barred from competition, but dogs not having a "TD" will be given preference in the Tracking Test by the tracking secretary. Up to 4 tracks may be set aside as specified in Chapter 1 Section 17d of the Tracking Regulations as amended to January 1, 2015 for test workers. The applicable number of entries from the workers will be drawn first. The remaining worker entries will be combined with the non-worker entries to draw for the remaining tracks.

NOTICE --The alternates have the option of accepting or declining to continue as alternates. Alternates who accept, and who are present at the test will have the opportunity of competing in place of an absent entry in the order established above. Alternates must notify the test secretary of their acceptance or declination within 10 days following the closing date. Failure to contact the test secretary within the given time period allowed shall constitute a declination. Alternates contacting the test secretary and exercising the right to decline within the time period shall have their entry fees returned.

BITCHES in season may participate under the conditions specified in Chapter 2 Section 8 of the Tracking Regulations as amended to January 1, 2016. The test secretary and judges must be notified of the bitch in season prior to drawing for tracks as specified below.

Tracking Test/TD tracking cover will be alfalfa hay fields and fallow crop lands (no grain stubble is anticipated).

These tests are held on private property. USRVDTC has no permission for the use of the property other than the requirements of the Tracking Test/TD. Driving on fields, littering, or other abuses of the property are not permitted.

Judging will begin at 8:00 a.m. MST.

**DRAWING OF TRACKS** Contestants for the TD Test will meet at Old Butte Park in Idaho Falls (also known as the Idaho Falls Soccer Complex). Directions to the draw: Drive west of Idaho Falls on US 20. Turn right (north) on N. 26<sup>th</sup> West. Proceed approximately one-third mile to Old Butte Park and turn left (west) on Clarence Drive. The draw will be held in the parking lot on the left-hand side of Clarence Drive. The drawing of tracks will be held promptly at 7:00 a.m. MST.

**AWARDS** Awards will be presented at the Tracking Test/TD. Tracking awards are wooden plaques with appropriate engraving. One of these awards will be given to each team passing their assigned tracks. Plaques will be awarded at the test site; the engraving will be mailed at a later date. These awards are made possible by the members of USRVDTC.

#### TRACKING TEST/TD RULES & REGULATIONS

#### **REFUNDS**

**Entry fees will not be refunded** in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Tracking Test Committee, or because the dog is ineligible to compete due to being entered incorrectly.

**No entry fees** will be refunded if the Tracking Test cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other causes beyond the control of the Tracking Test Committee. Refunds for cancellations due to judge change, overpayment of entries or cancellations made prior to closing date will be mailed to said Exhibitor or Agent after the tests.

Alternates accepting and present at the test who are not given the opportunity to compete shall have their entry fees returned. No refunds will be given for any reason other than those stated in this paragraph.

Dogs must be registered with the American Kennel Club or are registerable breeds that have obtained an AKC PAL/ILP number. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. - 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed.
