

first develop good criteria based on family, lifestyle, and personal preferences and then what to do when you meet that potential new dog (at the animal or elsewhere).

So many people head out to a shelter or to go see a litter of puppies without giving thought to just what they should be looking for. It's a long-term commitment and a great idea to sit down with the rest of the household and think it through before you head out. Is there a breed or mix of breeds you want, what size, what amount of dog hair are you willing to put up with, long coat-short coat, age, personality, and activity needs.
