#### TRACKING TEST RULES & REGULATIONS

#### **REFUNDS**

**Entry fees will not be refunded** in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Tracking Test Committee, or because the dog is ineligible to compete due to being entered incorrectly.

**No entry fees** will be refunded if the Tracking Test cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other causes beyond the control of the Tracking Test Committee. Refunds for cancellations due to judge change, overpayment of entries or cancellations made prior to closing date will be mailed to said Exhibitor or Agent after the tests.

Alternates accepting and present at the test who are not given the opportunity to compete shall have their entry fees returned. No refunds will be given for any reason other than those stated in this paragraph.

**USRVDTC** may decline any entries for cause and may refuse to receive, or may remove any dog on account of disease, viciousness, or other cause, and no one shall have any claim or recourse against USRVDTC or officials thereof.

DRAWING FOR PARTICIPANTS: If more entries are received than the limit; a drawing will be held on Saturday Sept. 12 at 6:00 pm at Tautphaus park near the fountain - South Blvd and Rogers Street.

**DOGS ELIGIBLE TO ENTER** Per AKC Rules and Regulations: The Tracking Test is for dogs not less than six months of age. With the entry form for the TD test of a dog, which has not passed a "Tracking Test", there must be filed a written statement by a person who is accredited by the American Kennel Club to judge a "Tracking Test", that the dog is considered by the judge to be ready for such a test. An exhibitor may enter more than one dog. The holding of other titles including "TD" shall not bar the dog from competition in the TD test. Entries without a Tracking Degree (TD) will be accepted first. There will be no actual scores for the TD or the TDX Test, but the dog will be rated "Passed" or "Failed" and a TD or TDX certificate will be issued by the American Kennel Club confirming all dogs rated "Passed".

Tracking Test/TD tracking cover will be alfalfa hay fields and fallow crop lands (no grain stubble is anticipated). Tracking Test/TDU will be held on a university campus and city park.

#### SAFETY, BEHAVIOR and LIABILITY

The drawing of tracks will be held promptly at 7:00 a.m. MST.

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
