No entry will be accepted, canceled, or substituted except as provided in Chapter 11, Sections 3-7, of the Rules Applying to Dog Shows. Facilities are NOT available for facsimile and/or credit card entries. Upper Snake River Valley Dog Training Club is NOT accepting online entries. Please mail entries so that they arrive on or before closing.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. The club and/or its Trial Secretary assumes no responsibility for wrong or incomplete information given by the owner or the owner's agent or for entering the dog in a class in which the dog is not eligible to compete. The club will retain a processing fee of \$5.00 per entry per trial.

Entry fees will not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Trial Committee, or because the dog is ineligible to compete due to being entered incorrectly.

Per AKC Rules and Regulations: This trial is open to all dogs over the age of 6 months that are registered with the American Kennel Club or are registerable breeds that have obtained an AKC PAL/ILP number, or AKC Canine Partners. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under six months of age are strictly prohibited from the trial grounds. Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form and the trial-giving club is offering the optional mixed breed classes.
