Once we have the shipment date of the new equipment, we'll notify the members and work together to unload trailers, put new equipment in, switch the old trial equipment to the practice trailer and sell the old practice equipment.

Alicia – During the agility trial at the Blackfoot Cluster, everyone in agility qualified in something – even dogs that have never qualified before- so it was a success for our club.

**Scent Work** — Nicki – Scent work trial at the Blackfoot Cluster had a trial profit of \$19.24. We had 4 judges. Next year we'll only do 3 days and have only 2 judges. Nicki wanted to specifically thank each of the people who helped with the scent trial. So, a BIG THANK YOU to Melissa, Lois, Duane, Cheryl!

October scent trial – we're still looking for a judge. We'll be offering buried and exterior with 60 dogs per trial.

CGC - Around July 26th.

**Classes**- There are 3 weeks of classes left for everyone but agility. There are 5 more agility classes. **Seminar Committee** – Suzanne – Obedience seminar August 5<sup>th</sup> or 6<sup>th</sup> with Patty Biggins. Randy Vanover came for an agility seminar in June, and he'll be back July 8<sup>th</sup>.
